

## **Artist Release and Waiver of Liability Agreement**

1. The Artist grants permission for their artwork to be displayed at Lake Forest Place, located at 1100 Pembridge Dr., Lake Forest, Illinois 60045. The location of the artwork will be in the Susie Morris Art Gallery.
2. The Artist hereby assumes all risks and hazards incidental to any participation in the display of their artwork at Lake Forest Place.
3. Artwork exhibited must be appropriate for viewing by all ages of the general public. Artwork that is of an overtly sexual, racist, violent, libelous, slanderous, demoralizing, or discriminatory nature is strictly prohibited.
4. The Artist represents and warrants that they are the sole legal owner of all right, title and interest in all Artwork and has the full right and authority to enter this Agreement and grant the rights granted herein.
5. The Artist is responsible for the delivery, pack, transport, provide for the return of their artwork the submitted artwork at their own risk and expense. The Artist or agents shall hang or display the artwork.
6. Display space is provided free of charge and is for the purpose of display only.
7. The Artist understands that the artwork is submitted to Lake Forest Place and exhibited at the Artist's own risk and that neither Lake Forest Place nor any of its board of directors, officers, agents, and employees shall be responsible for theft, vandalism, fire, or any other damages or losses to the artwork. The Artist understands and agrees that Lake Forest Place makes no representations or warranties regarding the level of security in the facility or on its premises. The Artists understands and agrees that Lake Forest Place and its board of directors, officers, agents, and employees will not be responsible for reimbursement or replacement of lost, stolen, or damaged items and that Lake Forest Place does not insure items such as the submitted artwork. The Artist understands and agrees that Lake Forest Place encourages the owner of the artwork or the owner's agent to obtain an insurance policy for the artwork or to obtain a rider on any existing policy for the duration of the exhibit.
8. Artist shall indemnify, defend, and hold harmless Lake Forest Place, its board of directors, officers, employees, volunteers, and agents from any and all claims, demands, causes of action and judgments, losses, costs and expenses, including but not limited to reasonable attorney's fees, arising due to the negligence of Lake Forest Place, their board of directors, officers, employees, agents or other personnel hereunder, including but not limited to any representation, warranty, term and/or condition of this Agreement.
